Subject: Extension of non-urban water metering compliance date to 1 June 2023 for Southern Inland NSW including the Murray Alluvial Groundwater Sources

Dear Licence/Approval Holder

Why am I getting another letter?

We recently wrote to you about the following water supply work approval to notify you about new metering conditions which would apply from 1 December 2022, unless a metering exemption applies. There have been changes made to your conditions since that letter was sent.

Approval(s): 50WA504692

What has changed?

Water users in the NSW Southern Inland region have been given extra time to install non-urban metering equipment in the wake of significant rainfall and widespread flooding. The deadline has been extended by 6 months and the new compliance date is 1 June 2023.

We have updated your licence and approval conditions which specified the previous date to reflect this new date. A list of the updated conditions is at the end of this letter. These updated conditions replace the conditions we previously added to your licence and approval. You can check a complete list of your conditions on the NSW Water Register at waterregister.waternsw.com.au.

Do I need to do anything?

You must comply with your existing conditions until 1 June 2023

You must comply with your existing conditions from the water sharing plan about metering and logbooks until 1 June 2023.

If your meter has been moved or damaged due to flooding, additional requirements apply

If a meter has been moved due to flooding—and is still operating properly—it must be reinstalled and revalidated by a duly qualified person.

If a meter has been moved or damaged due to flooding—and is no longer operating properly—a s91i self-reporting form must be submitted to WaterNSW.

This form must be submitted within 24 hours of becoming aware that the meter is no longer operating properly.

Any new metering equipment must comply with the new standards

If you are replacing old or damaged metering equipment, or installing new metering equipment, you must ensure your new meter complies with the new metering equipment standards. This requirement applies even if you install your new metering equipment before 1 June 2023.

If you need to install new metering equipment, act now if you can

While the timelines are being extended, water users who are able to install compliant metering equipment are encouraged to contact a DQP and put the technology in place well ahead of the new deadlines.
