WATERNSW

Entitlement charges are fixed charges associated with the cost of water delivery and relate to all licences based on entitlement/unit shares.

Water usage charges are based on metered or assessed water usage.

WATER ADMINISTRATION MINISTERIAL CORPORATION

Water management access charges are a fixed charge to provide water planning and management activities based on entitlement/unit shares by WaterNSW and Department of Planning, Industry and Environment.

Water management usage charges are based on metered or assessed water usage.

Water management minimum annual charge is a

fixed charge for combined access and usage charges.

PASS THROUGH CHARGES

The Murray-Darling Basin Authority (MDBA) and the Dumaresq-Barwon Border River Commission (BRC) undertake certain water and infrastructure management functions within Inland valleys. The MDBA and BRC are cross-jurisdictional bodies that co-ordinate and manage water resource management activities from a 'whole of system' perspective where more than one State is involved. These charges are collected by WaterNSW on behalf of these other organisations.
