



Upcoming fee changes

Some fees will be changing from 1 January 2021 for residential and small business customers in your state.

To make it easy to see what changes apply to you, we have included a table on the back that summarises the changes and where they apply – including the old and new fee amount. Where the fee applies to you, you'll see the fee on your future bills from this date.

Reason for the changes

Our fees are changing to reflect the current cost of providing various services to our customers.

Some new fees will apply from 1 January 2021.

What's changing?

For standard retail contract customers

From 1 January 2021, we will be charging a card payment fee, payment processing fee and paper bill fee on all products except where customers are registered for life support, hardship or concession. Other exclusions may also apply. You'll find more in our FAQ at originenergy.com.au/feesandcharges.

In summary:

- We'll apply a card payment fee for payments made using a Visa or Mastercard (debit and credit card). In NSW, a 0.49% (incl GST) fee applies for payments made by Visa and Mastercard over the counter at Australia Post outlets.
- Origin's payment processing fee (which is the higher of \$2.70 (incl GST) or 0.49% (incl GST) of the total payment amount) will apply if you pay over the counter at an Australia Post outlet (excl NSW).
- A paper bill fee of \$1.75 (incl GST) may be charged (excl NSW). This fee does not apply to customers registered for a concession, life support or hardship.

A standard retail contract is a regulated contract, where your prices are set at a standing offer rate which for NSW, QLD and SA customers matches the Default Market Offer pricing.
